### **Rules and Selection Guidelines for the Gabarron International Awards 2013**

#### **First:**

The academies, centers, foundations, cultural and research-based organizations, universities, other public and private institutions, and individuals invited by the Foundation may present formal proposals for candidates to the Gabarron International Awards according to the aforementioned requirements of each Award. Among their merits, they must have made an outstanding and exemplary contribution in their field, as well as a relevant international trajectory in each discipline.

Similarly, the members of each one of the Juries, prior to their establishment, may present proposals for candidates, as long as another two members of the Jury for that Award also give their support to the candidate proposed.

Proposals received from those who request the Award for themselves or for the organizations they represent will not be valid

#### **Second:**

Proposals for candidates must be presented through the following channels: by electronic mail to [awards@gabarron.org](mailto:awards@gabarron.org), by registered mail, by courier service, or in the registry of the General Secretariat of the Foundation in USA:

All proposals for candidates must be formalized by filling in the Official Proposal Form established for this purpose by the Foundation, or by sending a letter to the Foundation. Other documents, relevant data about merits and complementary information on the candidate may be enclosed along with other support for the proposal.

The proposal deadline for candidates is June 17, 2013 at 8 PM, except for those proposals made by the members of the Juries.

#### **Third:**

Proposals that do not fulfill the requirements previously indicated will not be admitted. Requests for the withdrawal or return of proposals or accompanying documents sent to the Foundation will not be answered; nor will the Foundation consider entering into correspondence on any of these questions.

#### **Fourth:**

Nine different Juries will be established, one for each Award. The Jury of each of the awards will be set up with sufficient time to consider the proposals and will be made up with no less than three and no more than seven members including a Chairman and Secretary appointed by the Foundation. Among the functions of the Secretary is the moderation of disagreements with respect to the Rules and Selection Guidelines that may arise among members of the Jury. It is the responsibility of the President of the Jury to chair the discussion, deliberations and voting.

#### **Fifth:**

Each member of the Jury will have one vote, which must be given personally by that member. The Award will be given to the candidate who receives the overall majority of Jury votes (at least four of six). In the case of a tie the President's vote will be a qualifying vote.

#### **Sixth:**

The Gabarron International Awards must be decided and the winners notified by October 1, 2013.

#### **Seventh:**

The Awards may not be of a posthumous nature, nor may they be given to the members of the Patronage of Foundation. Only one Award of each category may be given to an individual, workgroup or institution.

#### **Eighth:**

Each Award will be made up of a sculpture, original work of the artist Cristóbal Gabarrón, and a medal. The Award may not be shared.

In order to receive the sculpture and a medal, the winner must attend the Awards gala, unless unable to due to bad health or other reasons beyond his/her control.

#### **Ninth:**

Prizes will be awarded during a Ceremony to be celebrated in the city of New York, on **November 8, 2013** with all winners present.
